Orange Bowl Stadium CLINIC WAIVER



In return for being allowed to participate in the NFL Youth Football Clinic (the "Event") to be held January 27, 2007 at the Orange Bowl Stadium at 1501 N.W. 3 Street Miami, FL., 33125 I release and agree not to sue the National Football League, its thirty-two (32) member professional football teams, the Miami Dolphins, Ltd., NFL Properties LLC, NFL Ventures L.P., the City of Miami, the City of Miami Stadium Building Authority, Orange Bowl Stadium, the South Florida Host Committee, Inc., Miami-Dade County Public Schools, and including their elected and appointed officials, officers, directors, employees and volunteers, all boards, commissions and authorities and including board members, employees and volunteers, subcontractors, sponsors, agents, affiliates, subsidiaries, shareholders (collectively the "Releasees") from all present and future claims that may be made by me, my family, estate heirs, or assigns for property damage, personal injury, or wrongful death arising as a result of my participation in the Event and related activities, wherever, whenever or however the same may occur. I understand that and agree that those listed above are not responsible for any injury or property damage arising out of the Event, even if caused by their ordinary negligence. I understand that participation in the Event involves certain risks, including but not limited to, serious injury and death. I am voluntarily participating in the Event with knowledge of the danger involved and agree to accept all risks of participation. I consent to administration of first aid and other medical treatment in the event of injury or illness. I also agree to indemnify and hold harmless the Releasees for all claims arising out of my participation and related activities including but not limited to, transportation to and from the Event and medical treatment. I agree to let the Releasees use my name, likeness and demographic information free of charge in any manner and for any purpose in any media now known or hereafter developed.
